**8. 19.1745 Review of Planning Application P/25/507/HYB - Land West of Bridge (Land between Llangwydd Road and A473 Bridgend)**

***Resolved - Members had already discussed this application in detail at a pre meeting briefing and had listed their concerns for submission to BCBC.***

It was accepted that the land in question was one of five sites contained in the Local Development Plan earmarked for housing by BCBC but given the size of the development concern was expressed by members of the overall impact.

Members outlined the position that s106 month be used to support the plans for Bryntirion fields for large scale development.

Following detailed discussion the following concerns were highlighted:

- Lack of resources with regard to pressure on existing health provision
- Whilst development included a Primary School and recreation areas, concern expressed at long term impact on Secondary School provision.
- Access to and from site both for residents and construction vehicles

- Also as access through Laleston village would be restricted and intended via A48 (By Pass Road), impact on Broadlands
- Effect such large scale development will have on water table and drainage (possible flooding)
- Safety of pedestrians using Llangwydd Road and Gypsy Lane
- Effect on habitation of existing wildlife
- Close proximity to Laleston Cemetery

It was also felt that given the length of time that the development would take the Community Council would need to monitor issues as matters progressed.

**Resolved:** *The concerns be formerly submitted.*
